Processes for the 2025/26 Club Licensing and Club Monitoring – Key deadlines

Dear Licensing Managers,

In order to assist you throughout the 2025/26 season, please find enclosed the summary of the key club licensing and club monitoring deadlines that will need to be complied with during the 2025/26 season.

As in previous seasons, the club licensing and club monitoring information shall be submitted to UEFA via the CL/FS IT Solution unless otherwise specified or requested during the processes.

According to the *UEFA Club Licensing and Financial Sustainability Regulations – Edition 2024* ('CL&FS') and *UEFA Club Licensing Regulations for UEFA Women's Club Competitions Regulations – Edition 2024* ('CLWCC'), it is the licensors' responsibility to communicate these deadlines to all the affiliated clubs and to assess club's documentation. Each licensor is therefore required to define appropriate procedures and set internal deadlines to its affiliated clubs to allow sufficient time for the licensors to perform the required assessment before submitting the validated information to UEFA.

In particular, we would like to draw your attention to the following requirements and procedures related to club licensing and club monitoring for which licensors and clubs are required to submit information:

1. **Club Licensing:** As per CL&FS and CLWCC, licensors (and if applicable clubs) are required to submit the following information during the 2025/26 season:
 - **Club licensing national regulations:** submission of the final and approved national club licensing regulations for participation in UEFA club competitions and, if applicable, the exceptions request in relation to the club licensing provisions.
 - **"Three/Two-year rule" assessment process:** submission of the structural changes undertaken by the clubs and, if applicable, the exceptions request to the "three/two-year rule".
 - **Club licensing decisions:** submission of all licensing decisions taken by each licensor for the participation to the 2026/27 UEFA club competitions and, if applicable, the request for an extraordinary application of the club licensing system.
 - **Clubs' legal and financial information:** submission of clubs' financial, legal and ownership information related to club licensing.

2. **Club monitoring:** As per CL&FS, clubs admitted to the UEFA club competitions are required to submit the following information during the 2025/26 season:

- **Club information requirements:** submission of the club's legal group structure, its ultimate controlling party, its ultimate beneficiary and any party with significant or decisive influence over the club. Any changes to their club information occurring during the 2025/26 season must be promptly communicated to UEFA.
- **Solvency requirements** ("no overdue payables rule"): submission of detailed information to be assessed as at 15 July, 15 October 2025 and, if applicable, 15 January 2026.
- **Stability requirements** ("football earnings rule"): submission of club's financial data for the reporting periods ending in 2023, 2024 and 2025.
- **Cost control requirements** ("squad cost rule"): submission of club's financial data for the relevant 12-month period from 1 January up until 31 December 2025. Clubs with an annual accounting reference date on or before 31 July must submit interim financial statements

The deadlines applicable for the 2025/26 season are included in **Enclosures 1 for Club Licensing** and **Enclosure 2A or 2B for Club Monitoring** (depending on the club's accounting reference date) and are also available on UEFA.com.

Please note that the UEFA deadlines included in enclosures must be complied with by all (clubs and licensors) and are independent of any other deadlines set by the licensor as part of the club licensing process.

The auditor's declaration confirming the financial statements' compliance with the requirements of Annex G of the CL&FS must also be attached to the package.

³ In accordance with Paragraph 93.05 of the CL&FS, a club may request an alternative period for the squad cost ratio assessment. In such case, all reference to 31 December should be understood as 30 November. The club must confirm this choice in the CL/FS IT Solution.
